

# Outlook

- In FY21, AECOM posted sales of \$13.3 billion, up slightly from \$13.2 billion in FY20
- The company posted net income of \$173 million for the year, compared to a loss of \$186 million for 2020
- In 2020, AECOM divested its Management Services in a \$2.4 billion deal to Amentum, which owns the majority of AECOM's federal government support and services contracts
- AECOM now focuses on government construction services

AECOM was originally formed as the Ashland Technology Company in 1980, as a wholly owned subsidiary of oil and gas refiner Ashland Inc.

The unit was spun off as a private, independent company in 1990, named AECOM Technology Corporation. The company went public with a stock offering in May 2007 on the NYSE, where it is listed as "ACM."

Since its privatization, the firm has grown through a series of mergers and acquisitions. These acquisitions have included McNeil Technologies Inc, a government national security and intelligence services firm, in August 2010; and Tishman Construction Corporation, a provider of construction management services in the United States and the United Arab Emirates, in July 2010.

In October 2014, AECOM Technology acquired URS in a transaction valued at roughly \$4 billion. The transaction, which doubled the size of the firm, brought together companies that provide support and planning services for governments and large engineering and construction projects.

In February 2020, AECOM sold its Management Services business in a \$2.4 billion deal. Now operating as Amentum, the new company encompasses a majority of AECOM's former government-related support and services operations.

Today, the company is a global provider of professional infrastructure consulting services for governments, businesses and organizations throughout the world. AECOM offers planning, consulting, architectural and engineering design, construction, and program management services and investment and development services to commercial and government clients in major end markets such as transportation, facilities, environmental, energy, water and government.

# **Corporate Overview**

AECOM ranks as a top infrastructure consulting firm, delivering professional services throughout the project life-cycle – from planning, design, and engineering to program and construction management. The company focuses on the transportation, facilities, environmental, energy, water, high-rise buildings, and government markets. For these markets it provides planning, design, systems engineering and integration, technology development, program and construction management services, and operations and maintenance services. Clients include federal, state, and local government agencies in the United States and Fortune 500 corporations and government customers around the world.

#### **New Products and Services**

**NASA Facility Support.** In September 2021, AECOM was selected by NASA to provide architecture

and engineering services as part of its Southeast Regional Architect and Engineering (SERAE) program. The indefinite delivery/indefinite quantity (IDIQ), multiple-award contract has a shared program ceiling of \$300 million for its five-year term. AECOM's work will focus on the rehabilitation, modernization, and development of new systems for facilities, utilities, and ground support at several NASA locations, including Kennedy Space Center in Florida; Johnson Space Center, Sonny Carter Training Facility, and Ellington Field in Texas; White Sands Test Facility in New Mexico; Marshall Space Flight Center in Alabama; Michoud Assembly Facility in Louisiana; Stennis Space Center in Mississippi; other NASA assets; and additional launch or landing sites worldwide. Services will include architectural design, field investigations and surveys, engineering and environmental reports, trade studies, provision of design specifications, construction site inspections, and scheduling and cost estimating.

**USAF Architect-Engineer NEXT 2021.** In March 2021, the U.S. Air Force Civil Engineer Center (AFCEC) selected AECOM to provide planning, design, and construction management services through the Architect-Engineer NEXT 2021 contract for infrastructure and facilities globally. The multiple-award contract, with a combined \$2 billion program ceiling, includes a five-year base period and one five-year option. AECOM had held AFCEC's predecessor architect-engineer contract for the past five years.

**USAF Sijan Hall Modernization.** In November 2020, AECOM announced that the U.S. Army Corps of Engineers, Omaha District, had selected the firm to design the renovation of the U.S. Air Force Academy's 700,000-square-foot Sijan Hall, which is located just north of Colorado Springs, Colorado. The dormitory is situated in the campus's Cadet Area, which is a National Historic Landmark District. This will be the first modernization project at Sijan Hall since it was built in 1968, with the design encompassing residential, academic, courtyard, and recreational spaces. The contract is valued at \$25 million.

**NASA Remediation.** In March 2019, AECOM was awarded a \$300 million contract from the National Aeronautics and Space Administration (NASA) to investigate, design, and implement environmental remedial actions at the agency's Kennedy Space Center in Florida, the adjacent Cape Canaveral Air Force Station, and other NASA centers nationwide. The firmfixed-price, IDIQ contract has a performance period of February 2019 through February 2024, with a maximum combined value of \$300 million. AECOM will provide architectural and engineering services to develop and implement contamination assessment and remediation



requirements for designated Resource Conservation and Recovery Act (RCRA) and Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) sites located on NASA properties.

U.K. Nuclear Deterrence. In January 2019, AECOM and AWE plc signed a contract naming AECOM as the delivery partner to AWE for its Nuclear Capability project, a key component of the U.K. government's nuclear deterrence program. The scope of the contract includes the decommissioning and demolition of current facilities, the completion of new facilities, and the management and transportation of material across sites. The contract, for an initial commitment of GBP2 million (\$3 million), has a potential value of GBP360 million (\$500 million) expected to span at least 12 years. In the U.K., AECOM is the lead member of the Parent Body Organization that manages the Low Level Waste Repository in Cumbria. It is also a member of the Parent Body Organization at the Dounreay nuclear site near Thurso, Scotland.

#### Plant Expansion/Organization Update

**HQ Relocated.** Effective October 1, 2021, AECOM relocated its global headquarters from Los Angeles, California, to Dallas, Texas.

**COVID-19 Impacts.** Over the course of 2020, AECOM received several contracts related to the creation of alternate care facilities for COVID-19 patients. The company assisted in operations in New York and Chicago, and in Rhode Island, early in the crisis. In addition, the firm partnered with the U.S. Federal Aviation Administration (FAA) to support the agency's continued operation of the critical national airspace system during the pandemic. Following the outbreak of the pandemic in the United States, AECOM's environmental and disaster response experts, along with a network of nationwide disinfection teaming partners, began helping the FAA maintain continuity of airspace operations.

#### Mergers/Acquisitions/Divestitures

**Civil Construction Sold.** In January 2021, AECOM completed the sale of its civil construction business to affiliates of Oroco Capital, a strategic infrastructure investor. In October 2020, the company sold its power construction business to affiliates of CriticalPoint Capital, LLC. With these two divestitures, the company exited substantially all of its self-perform, at-risk construction businesses. Terms were not reported.

**Management Services Divested.** In February 2020, AECOM divested its Management Services business to affiliates of American Securities and

Lindsay Goldberg for a purchase price of \$2.4 billion. Included with this sale was the Rotary Wing Flight Training unit at Fort Rucker. AECOM had been providing military rotary-wing training services at Fort Rucker since 1989.

Under its new ownership, the former Management Services operations are now known as Amentum, a privately held company. Amentum focuses on the following sectors: Nuclear & Environment, Mission Support & Sustainment, Threat Mitigation, Mission Assurance, Strategic Capabilities Engineering in Critical Infrastructures, Facilities, and Ranges in the U.S. and abroad.

In September 2020, Amentum acquired DynCorp International, a global services provider. The expanded firm would employ 34,000, with an estimated \$6 billion in revenue.

**Shimmick Construction Acquired.** In July 2017, AECOM acquired Shimmick Construction, a heavy civil infrastructure construction firm in the California and western U.S. markets, for \$175 million. Shimmick has approximately 1,000 employees and a backlog that includes a wide portfolio of iconic infrastructure projects.

**FT Services Acquire.** In October 2016, AECOM acquired the remaining 50 percent equity interest in FT Services Ltd (FTS), a joint venture company based in Calgary, Alberta. Formed in January 2007 between Flint Energy Services Ltd, an AECOM subsidiary, and Broadspectrum Ltd, FTS specializes in large-scale maintenance and turnaround services for the Canadian resource and energy industry, including oil sands, refining, chemical, midstream, and other heavy industry facilities. The unit employs 2,000. Terms were not announced.

**URS Acquired.** In October 2014, AECOM completed its acquisition of URS Corporation in a deal valued at \$6 billion. The acquisition of URS gives AECOM a stronger foothold in the power distribution and oil and gas industries. In addition, URS brings a solid federal contracting portfolio, with major U.S. Energy Department and U.S. Army contracts. The combined company had revenues of \$19.2 billion as of mid-2014 and employs some 100,000. The deal was first announced in July 2014. Integration into AECOM was completed in 2015.

**Hunt Construction Acquired.** In July 2014, AECOM acquired privately held Hunt Construction Group. Hunt, which employs 700 people in nine U.S.

offices, had 2013 revenue of \$1.2 billion from providing construction services for sports stadiums, airports, and other larger projects. Terms of the transaction were not announced.

#### **Teaming/Competition/Joint Ventures**

**BakerAECOM.** This joint venture with Michael Baker International provides services for the U.S. Federal Emergency Management Agency's Risk Mapping, Assessment and Planning (Risk MAP) program. Member companies include Michael Baker Corp, AECOM, Gannett Fleming, and Taylor Engineering Inc.

In 2022, this JV was awarded a five-year contract with a \$75 million ceiling, to deliver architecture and engineering services in support of environmental compliance programs of the U.S. Naval Facilities Engineering Systems Command (NAVFAC).

In 2014, this JV was awarded a \$60 million contract for general and design architect-engineer services for U.S. Central Command.

**Cardno TEC-AECOM Atlantic.** Founded in 2013, this joint venture of AECOM and Cardno of Australia provides engineering services.

**CDM-AECOM Multimedia.** Formed in 2013, this joint venture provides engineering services. In September 2014, the venture was awarded an \$85 million contract to provide architectural and engineering support for the U.S. Defense Department's environmental compliance initiatives. The company would help prepare sustainability program studies, specifications, and cost estimates for organizations within the Naval Facilities Engineering Command's Atlantic area of responsibility. Work was scheduled to be completed by September 2019.

**CTI-URS Remediation and Environmental Services.** Formed in 2011, this joint venture between CTI and URS (CURES) provides environmental remediation services. The venture is working with the U.S. Army Corps of Engineers on various efforts, including program/project management, compliance, conservation, pollution prevention, restoration, sustainment, readiness, and modernization activities supporting military, civil, and federal agencies.

**Hybrid Air Vehicles.** In March 2022, AECOM partnered with Hybrid Air Vehicles (HAV) to provide infrastructure services for its hybrid aircraft, Airlander. AECOM will advise on hydrogen supply infrastructure and transit interchange design. In addition, AECOM will work with HAV to develop the Airlander 10 manufacturing facility. Additional joint work on the larger Airlander 50 and other projects is expected.

**IAP.** IAP Worldwide Services and URS Corporation formed a joint venture dubbed URS-IAP LLC. The venture is performing work for the Navy's Global Contingency Construction program. The GCC program provides construction and related engineering services to support Navy warfighters in natural disaster recovery, humanitarian assistance, and emergency contingency response.

**ManTech-AECOM.** This joint venture of AECOM and ManTech International provides engineering and IT services.

**Pixel Velocity.** In December 2014, URS formed an alliance with Pixel Velocity Inc (PVI) to deliver stateof-the-art capabilities for strategic oil and gas infrastructure protection and security. The URS-PVI team offers a fully integrated enterprise-level security and asset protection solution to contain and defeat physical, cyberspace, and electromagnetic spectrum (EMS) threats.


**TEC-AECOM Pacific.** This joint venture of AECOM and Cardno of Australia provides engineering services.



### **Strategic Outlook**

Following a period of restructuring, AECOM has settled down. The company struggled a bit after acquiring URS, which doubled the size of the company, making it one of the largest – if not *the* largest – engineering firms in the U.S. Not only did the purchase expand AECOM's presence in the power distribution and oil and gas industries, but it also increased the firm's federal contracts portfolio.

As it worked to absorb the operation, AECOM made a series of divestitures. In 2019, the company spun off its private infrastructure investment arm, AVAIO Capital. This was followed in 2020 by the sale of its Management Services arm to affiliates of American Securities LLC and Lindsay Goldberg for \$2.4 billion, which run it as Amentum – named after the leather strap attached to a javelin used in ancient Greece. More recently, AECOM closed on the sale of the Power and



Civil Construction businesses in October 2020 and January 2021, respectively, and the sale of the Oil & Gas maintenance business and the turnaround Services business in January 2022.

In terms of government programs, most are now operated by the privately held Amentum. Amentum provides federal government customers with services in the areas of mission support and equipment sustainment, information technology, intelligence, nuclear and environmental remediation, threat mitigation, mission assurance, facility maintenance, and range services in the U.S. and abroad.

Because of these strategic actions, AECOM will be focused on what it sees as a high-returning professional services business. Its remaining portfolio will offer design, planning, architecture, engineering, program

management, and construction management services. Due to this change, this report will likely be archived in

the next cycle.

# **Program Activity**

Some important aerospace and government programs currently underway are listed below.

#### **Contract Vehicles**

Contract vehicles offer federal agencies a convenient mechanism for obtaining a wide variety of management and technology services.

Indefinite delivery/indefinite quantity (IDIQ) contracts provide for an indefinite quantity of services for a fixed time. They are used when the U.S. General Services Administration (GSA – www.gsa.gov) cannot determine, above a specified minimum, the precise quantities of supplies or services the government will require during the contract period. IDIQs help streamline the contract process and speed service delivery. IDIQ contracts are most often used for service contracts and architect-engineering services.

Under the GSA Schedules (also referred to as Multiple Award Schedules and Federal Supply Schedules) program, GSA establishes long-term government-wide contracts with commercial firms to provide access to over 11 million commercial supplies (products) and services.
